

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 24/01/2018 considered the Compliance Verification Assessment Report (15/12/2017) along with the Council Assessor's Report (June, 2017) and compliance dated 28/09/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats at S S Institute of Medical Sciences& Research Centre, Davangere granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (15/12/2017) along with the Council Assessor's Report (June, 2017) and compliance dated 28/09/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Paediatrics) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S S Institute of Medical Sciences& Research Centre, Davangere be recognized and included in the 1st Schedule to the I.M.C.
