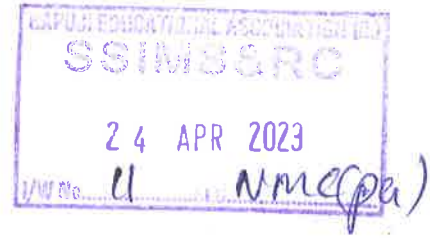

S. Institute of Medical Sciences & Research Centre, Davangere under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
