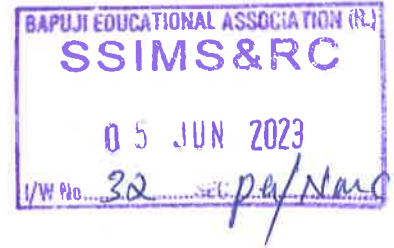


Sir/Madam,

S.
