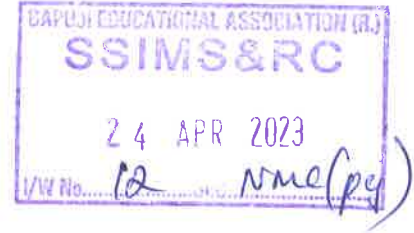



S.
